Submission Requirements

All information needs to be submitted via the online nominations form into the text boxes provided. All entries must provide an "Overview" (300-500 words) which gives a short executive summary of the project/individual. Please note that the Overview will be published in the SCLAA Newsletter once the shortlist is announced, so we kindly request you do not provide confidential facts or figures within this summary.

Compulsory Requirements

Entries must include:

- A one-page testimonial of endorsement which includes name, position, contact number and email.
- Company logo*
- Team or Individual photo of the nominee(s)*

**Both must be high resolution, minimum 300dpi and in JPEG, PNG or EPS format.*

Supporting Materials

You may, if you wish, upload additional material to support your entry. However, this must be limited to 4 x uploads and should not comprise of information that is central to your case - the judges will expect to see this in your main submission.

Supporting material may include the following:

- PowerPoint
- Video/Image
- Press clippings
- Performance figures

Please note: Unless stated otherwise, the project name given on the entry form is the name that will be used throughout the campaign, on all marketing communications and material, including certificates and trophies, if applicable. We reserve the right to shorten entry titles for the purpose of the awards announcements.

Future Leaders Award

The Future Leaders' category has an additional interview stage for all those selected as finalists – these interviews will be booked and conducted from September 2025 (date to be confirmed), and serve to broaden the judges' understanding of the submissions before a final decision is made.

Environmental Excellence Award

This award requires nominees to answer how they meet the following additional criteria within their submission:

- Outline how your project or initiative relates to an environmental goal or environmental improvement.
- Outline how you measured the success of the initiative or project.
- What were the benefits of this initiative and who benefitted?
- Outline any further impact that may have come from the project or continuous improvement outcomes seen.

ASCL Industry Excellence Award

Award Criteria:

- Must be an Australian resident.
- Achievement that has provided change, improvement, education, support, development, implementation, or significant results that has bettered their own or general supply chains or the industry as a whole.

ASCL Future Leaders Award

Award Criteria:

- Any person 30 years or under that has shown proven commitment to learn and gain knowledge and has applied their achieved skills to deliver improvements within their supply chain field.
- Particular attention will be given by the judges where nominees have been encouraged and able to use new techniques, technology or developed new processes.

ASCL Training, Education & Development Award

Award Criteria:

- Open to all training, education and development initiatives where benefits to the company and/or employees is demonstrable (In the case of training bodies or Academic institutions, impact on the industry as a whole will be considered).
- Must demonstrate commitment to, investment in or active ongoing development of supply chain industry participants.

ASCL Supply Chain Management Award

Award Criteria:

- Must be an organisation or company not an individual - open to all Industries.
- Nominees should be able to clearly state the design and achieved results of the project or process envisaged and then implemented.
- Must be a general measurable improvement of the entire Supply Chain or a part thereof.

ASCL Automation, Robotics or Emerging Technology Award

Award Criteria:

- Open to organisations who have implemented or who consult on, or implement, emerging technologies to improve supply chains or an aspect of the supply chain.
- Outline the business issue that was addressed.
- Demonstrate how this was implemented and the measurable impact of that change.

ASCL International Supply Chain Award

Award Criteria:

- Must demonstrate impact on Australian supply chains, or the expansion of ideas, products, systems or processes from Australia to overseas markets.
- Can be an individual or organisation.
- Must have an international aspect to the submission under definition.

ASCL Environmental Excellence Award

Award Criteria:

- Must be able to demonstrate leadership towards environmental goals or a project relating to the improvement of the environment.
- Must be a measurable result(s).
- A service or initiative that clearly contributes to sustainability through a change in processes, or reduction or re-use in energy, waste, materials or natural resources.

ASCL Start-up Award

Award Criteria:

- Open to all industries related to supply chain and can be from any sector servicing the supply chain.
- Must be under 7yrs old as a registered entity.
- Must have essentially started the business/service/ company from scratch (i.e. not inherited or purchased an ongoing business).

Transport Logistics Excellence Award

Award Criteria:

- Must be an organisation or company not an individual - open to all Companies involved in the physical movement of goods/cargo.
- Nominees should be able to clearly demonstrate their point of difference, any innovative practices that resulted in exceptional service levels to their customers or resulted in a change of industry practices overall.
- Must include company growth statistics and 3rd party testimonials to justify the applicants exceptional service levels.

ASCL Big Data, IT & Business Intelligence (BI) Award

Award Criteria:

- Must be a software, data, application or systems improvement.
- Must explain the issue being addressed.
- Nominees will demonstrate where the use of Big Data, IT, BI or data-driven systems have significantly impacted their IT management and/or their supply chain processes.

Workplace Health and Safety Award

Award Criteria:

- Must be an organisation or company not an individual - open to all Industries.
- Nominees should be able to clearly state the design and achieved results of the project or process envisaged and then implemented.
- Must be a general measurable improvement to workplace health and safety within their organisation.

ASCL Judges' Choice Award

Award Criteria:

- The winner of this Award can be an individual or organisation working or operating in Australia. The recipient of this award is nominated by the Judging panel, the SCLAA Board or can be selected from any of the submissions.
- The nominees will be judged on their demonstration of a clear application of Logistics Improvement that is unique, innovative or reforming to the organisation or the industry.
